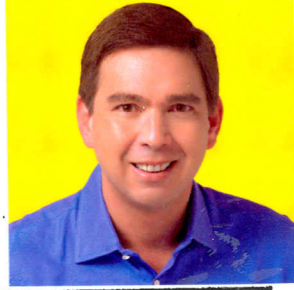

4. Titles such as 'Dr., Atty., Don, Ginoo, Señor, Datu, Hadji, Sultan, Bal, Señora, Kapitan or similar titles are expressly prohibited.
5. This certificate shall be sworn before a notary public or any official authorized to administer oath. COMELEC officials are not authorized to administer oath.
