Voter Registration System Machines for the Overseas Absentee Voting
(BAC Reference No. 2011-001OAV)

In connection with the 31 August 2011 *Pre-Bid Conference* anent the subject procurement, the public and the prospective bidders are hereby informed of the following matters:

(1) Technical Specifications

Issues	Answers/Clarifications
(1) What is the speed specification for the processor of personal computer stated in Item (1) (Personal Computer)?	It is Intel core i3 processor.
(2) What kind of Windows 7 is stated in the Technical Specifications?	It must be Windows 7 Professional (32-bit)
(3) Is the Laser Printer colored?	No. The Laser Printer should be monochrome.
(4) Is it necessary to submit the source code for Finger Print Scanner?	Yes.

(2) Delivery Schedule

Issue/s	Answers/Clarifications
(1) Can the delivery schedule of three (3) days be extended?	No, due to tight schedule for the registration of overseas absentee voting scheduled on 31 October 2011 per COMELEC Resolution No. 9269. In any event, future stipulations concerning rights and obligations of parties, including delivery schedule, shall be subject to an agreement to be entered into by COMELEC and the supplier.

(3) Other Terms and Conditions of Bidding Documents**(a) Taxes**

Pursuant to Section 28.6 of the Instructions to Bidders (Bidding Documents), in relation to Section 32.2.2 of the Revised Implementing Rules and Regulations of Republic Act No. 9184, all prospective bidders shall include in their bids the cost of all taxes, such as, but not limited to, value added tax (VAT), income tax, local taxes, and other fiscal levies and duties which shall be itemized in the bid form and reflected in the detailed estimates. Such bids, including said taxes, shall be the basis for bid evaluation and comparison.

(b) Approved Budget for the Contract (ABC)

The bidder may either bid for the entire lot with an ABC of Php11,769,800.00, or per item, or aggregate of items, *provided*, the financial offer for each item shall not exceed the ABC established therefor.

Accordingly, the fifty (50%) similar and single completed contract shall be based on the total amount of items being offered by the bidders.


All terms, conditions and instructions to bidders specified in the Bidding Documents consistent with this Bid Bulletin shall remain in full force and effect.
